I hereby acknowledge that participating in fishing activities is a hazardous sport. Fishing activities present a risk of personal injury, death and damage and/or loss of personal property.

The risks relate to numerous factors, including but not limited to, being on or near bodies of water, boarding and disembarking of watercraft(s), natural hazards, lightning storms and other adverse weather conditions, domestic and wild animals, fire, foot travel to and from vehicles and watercraft, travel in unfamiliar terrain, artificial and natural obstructions, travel over unimproved roads, fences and terrain.

I hereby acknowledge and recognize the existence of these risks, and hereby ASSUME ALL RISKS, whether known or unknown, to which I may be exposed while engaged in any activity under the sponsorship of The Krafty Angler Fishing Guides. Further, I agree to hold The Krafty Angler Fishing Guides **harmless from all claims, demands, damages, actions, causes of action, or suits in equity of whatsoever nature, whether in tort (including acts of negligence) or in contract, whether now known or that may become known in the future relating directly or indirectly to the guide services provided by The Krafty Angler Fishing Guides, its owners, agents, officers, and/or employees, heirs, successors and assigns. This indemnity specifically includes attorney's fees and applies to injury, death, property damage or loss from any activity that may occur at any stage of a fishing package trip(s) with The Krafty Angler Fishing Guides.**

I understand and acknowledge that by signing this document I have given up certain legal rights and/or possible claims, which I might otherwise assert or maintain against The Krafty Angler Fishing Guides, its owners, agents, officers and/or employees. These rights are specifically, but not limited to, rights arising from claims or demands for acts of omission or negligence in any degree, including gross negligence, of The Krafty Angler Fishing Guides, their guides, aides and all other related persons or entities. Under no circumstances will the Krafty Angler Fishing Guides and/or its owners, agents, officers and employees be held liable for damages in excess of the actual cost spent on the particular trip.

I understand that this contract reflects our entire agreement and that my signature indicates that I have read and understand this document and that I have signed this document of my own free will.
